Waste management-how important is it?

Covid19 is generating a lot of extra waste, in particular the waste from disposable face-masks. It takes 450 years for a disposable facemask to break down. (Figure 1) Therefore it is important to manage face-mask waste in a responsible way. In 2020, 1.6 BILLION face-masks found their way into the ocean.

Disposable face-masks are made from micro-sized* plastic fibres that can-

* (1) micro-sized plastic fibres are 1-10 micrometres thick

Cannot be easily biodegraded. Facemasks that end up in our environment, are broken down by a process called weathering.*² Scientists like Dr. Genbo Xu who study plastic pollution, have found that disposable facemasks in our waterways release dangerous micro sized particles*³ in only a few weeks, and then break down into even smaller particles*⁴ harming marine life, bird life and humans! (Figure 2)

*⁽²⁾ weathering e.g. - from the sun, air, heat, moisture

*⁽³⁾ micro sized particles are smaller than 5mm

*⁽⁴⁾ particles smaller than micro sized are less than 4 micrometre

On 6 April 2022, I presented to my School leadership team (Figure 3) about introducing Terra-cycle facemask recycling bins for our School Community.

Facemasks can be recycled into plastic pellets to make many new products, including park benches and decking. Australian scientists have even found a way to use recycled facemasks as material for roads. Waste management of disposable facemasks is extremely important for the future of our environment.


